A FEW TRANSACTIONS AT HIGHER PRICES—PORK OPENED 5 CENTS LOWER.

Chicago, July 25.

This morning's openings placed July wheat 1/8 higher, Sept. ribs 1/4 higher, and Oct. Lard 3/8 higher than their closing prices yesterday, and showed Sept. and Dec. wheat, July corn, Sept. and Dec. oats, Sept. Lard and Dec. ribs selling at the same prices; they also found Sept and Dec. corn 1/2 lower, and all the porks at 1/4 lower than they were doing at yesterday's close.
