

Mr. Dupré, a Member of the King's Privy Council, for Mr. Gordon, presented,—Return to an Order of the House of the 19th October, 1932, for a statement of moneys expended by the the Department of Labour for the relief of unemployment in the county of Bonaventure since the first of August, 1930, up to date, specifying the localities where such works were done and who was in charge, together with the amount of relief granted and the name of each municipality in which such moneys were expended and by whom were such expenditures made.

Mr. Stevens, by leave of the House, introduced a Bill, No. 9, An Act to amend The Canada Grain Act (Domestic grain), which was read the first time, and ordered for a second reading at the next sitting of the House.

The following Order of the House was issued to the proper officer under subsection 4 of Standing Order 44:—

By Mr. Girouard:—Order of the House for a Return showing:—

1. Whether the Governor in Council, under The Relief Act, 1932, loaned or advanced money to, or guaranteed the payment of money by any public body, corporation or undertaking.

2. If so, on what date.

3. The names of the public bodies, corporations or undertakings to whom money has been so loaned or advanced or to whom such guarantee has been given.

4. The amount so loaned or advanced or guaranteed to each public body, corporation or undertaking.

Mr. Rhodes, a Member of the King's Privy Council, presented,—Return to foregoing Order, forthwith.

The following Order of the House was issued to the proper officer:—

By Mr. Ralston:—Order of the House for a copy of all correspondence, letters, telegrams and other documents respecting the repairs, during the years 1931-32, on the breakwater at Comeau's Hill, Yarmouth county, Nova Scotia, showing the name or names of all the foremen, the nature of the work done, the bills for materials and supplies, time sheets, vouchers and other papers.
