DEPARTMENT OF JUSTICE RULINGS

Sir EUGENE FISET (for Mr. Pouliot):

For a copy of all rulings of the Department of Justice and part III of the Consolidated Revenue and Audit Act, 1931.

Mr. CARDIN: I suggest that this order cannot be complied with in the general terms in which it is prepared. The order asks for all rulings of the Department of Justice. I am informed that it is practically impossible to prepare a list of all the rulings that have been given, without any limiting date. Moreover, generally speaking, the rulings of the Department of Justice are more or less confidential and have never been requested for a period as extended as the time covered by this motion. It is true that rulings of the Department of Justice can be produced with respect to some determined matter; for the minister is then in a position to decide whether it is in the public interest that such rulings be given publicity. Again, some of these rulings may affect pending cases; and the Minister of Justice being absent, it might imply a change in the practice with regard to rulings of the department. I would ask the hon. gentleman to let the motion stand until the return of the Minister of Justice (Mr. Lapointe).

My right hon. friend knows that there has to be some latitude left with regard to bills which it may be found necessary to introduce at the last minute. I think, however, the house has now before it notice of practically all important measures except one relating to parliamentary undersecretaries, to which reference will be made after the Easter recess. Concerning the budget, I am not in a position to give my right hon, friend a statement at the present time as to the exact date, but no doubt the Minister of Finance (Mr. Dunning) will be able to answer my right hon. friend's question very shortly after the house resumes, following the Easter recess.
