Second, will the Prime Minister give the house the assurance that in whatever discussions are going on at the moment, of which he has said he has no knowledge, nothing will be done to deal with the transfer of Indians from federal authority without the consent of the Indians themselves; because I am sure he will agree that any other course would be to place them in the position of being chattels.

Mr. Pearson: Mr. Speaker, I agree with the latter part of the right hon. gentleman's observation. So far as the first part is concerned, I shall give a detailed answer tomorrow.
