WAR VETERANS ALLOWANCES—PROVISION TO RECIPIENTS OF BENEFIT OF ESCALATION PENDING NEW RATES AND CEILINGS

Mr. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, may I direct a question to the Minister of Veterans Affairs. Can the minister say whether the necessary order in council has been passed, one similar to those of the last two or three years, so that war veterans allowance recipients who are also receiving the guaranteed income supplement will obtain the benefit of the escalation which will be in effect for the next three months, pending the new rates and new ceilings which are to come into effect in April?

Hon. Jean-Eudes Dubé (Minister of Veterans Affairs): Not yet, Mr. Speaker.

Mr. Knowles (Winnipeg North Centre): Is consideration being given to this being done before the January cheques go out?

Mr. Dubé: Yes, Mr. Speaker. It is under consideration at the present time.

Will the minister consider forgoing the reduction in war veterans allowances of 21 cents in some cases and 42 cents in many other cases as a result of changes in the old age pension legislation, since the administrative cost of making such changes would be much greater than the actual reductions in expenditure in many cases?

farmers may be able to understand the operations of the Wheat Board which handles their very vital product?

Mr. Lang: Mr. Speaker, the report, as I said, is a report to the Wheat Board. I would want to discuss this matter with them. I presume I will be able to do that soon after they have received the report.
