That this House demands the minister responsible for the status of women be immediately relieved of his duties in order to restore the independence of the advisory council.

# PROPOSED CONNOISSEUR SERVICE—MOTION UNDER S.O. 43

That this House direct Air Canada to renounce second-class treatment for the people of Saskatchewan, Manitoba and Atlantic Canada and initiate its new connoisseur service on all domestic flights effective February 1, 1981.
