Mr. Mike Cassidy (Ottawa Centre): Mr. Speaker, I have the honour to present a petition from a number of citizens of Ottawa pointing out that the proposed cut in the old age pension will take from old age pensioners \$100 in 1986, \$205 in 1987, and \$315 in 1988, and they are asking this House to reinstate full indexation of the Old Age Security Program of Canada.

I have another petition, also signed by a number of residents and pensioners of the City of Ottawa, who petition the House of Commons to reinstate the full indexation of the old age pension and who recall that during the election campaign, Progressive Conservative Members stated that a PC Government would once more index the old age pension to the actual cost of living on a quarterly basis. They are asking that that promise be kept.

Mr. Jim Manly (Cowichan-Malahat-The Islands): Mr. Speaker, Canadians from coast to coast are getting very concerned about the lack of indexing on pensions. It is my privilege to present a petition from citizens, who are mostly from Saskatchewan, protesting the Government's action in cutting the indexation of Old Age Security, reminding the Government of its promise to index pensions fully, and urging that indexing be fully restored.

Mr. Dan Heap (Spadina): Mr. Speaker, I have the honour to present a petition from citizens of Canada reminding the Government that it promised to restore full indexation of pensions and requesting Parliament to see to it that that full indexation is in fact restored.

Mr. Vic Althouse (Humboldt-Lake Centre): Mr. Speaker, I have a petition to present from some residents of my riding who are petitioning the Government to reverse its policy on deindexing Old Age Security Program payments because of the ultimate high cost to pensioners. They are asking that the Progressive Conservative Government live up to its election promise to continue the indexing of pensions on a quarterly basis based on the actual cost of living.
