

ance Act or the *Civilian War Pensions and Allowances Act* to a person who had been at any time a recipient under such Act but who ceased to be qualified to be a recipient under such Act before the coming into force of this Act, an allowance is payable to the person for that period under this Act and the *War Veterans Allowance Act* or the *Civilian War Pensions and Allowances Act* as if during that period he had been a recipient under such Act.

Your Committee has ordered a reprint of Bill C-4, as amended, for the use of the House of Commons at the report Stage.
