## MONTREAL TELEGRAPH CO.:

1. Petition for an Act to consolidate the several Acts respecting the Company, &c., 44. Report of Notice, 143. Bill presented, 145. Referred, 155. Reported, with amendments (Preamble amended), 280. Committed; Amended; Considered; Motion for third reading; Amendments moved to recommit the Bill; 1. By Mr. Blake, for the purpose of providing that no Act which may hereafter be passed, under certain circumstances reducing the maximum rate which may be charged under the Bill, shall be deemed an infringement of the privileges granted by this Act; Negatived; 2. By Mr. White (Cardwell), for the purpose of restricting the clauses relating to leasing and amalgamation to companies or telegraph lines already established, 292. Carried; Main question as amended agreed to, 293. Bill recommitted and amended accordingly; Considered; Agreed to. 3. By Mr. White (Cardwell), to provide that the rates charged by any company leasing the lines of the Montreal Telegraph Company, shall be at all times charged equally to all corporations and persons without discrimination, &c.; Negatived. 4. By Mr. White (Cardwell), to provide that the maximum rate chargeable on despatches shall be twenty cents per ten words, instead of twenty-five cents, 294. Negatived; Bill read a third time and passed, 295. By the Senate, with amendments; Considered; Agreed to, 402. R.A., 518. (41 Vic., c. 93.)
