PUBLIC SERVICE

TABLING OF REPORT OF CIVIL SERVICE COMMISSION

Right Hon. J. G. Diefenbaker (Prime Minister): Mr. Speaker, I wish to table two copies in English of the report of the civil service commission of Canada entitled "Personnel Administration of the Public Service". You will recall that Mr. St. Laurent, the former prime minister, suggested that there be this investigation. Mr. Arnold Heeney as chairman of the commission and Miss R. E. Addison and Mr. Paul Pelletier as members undertook a study of the many complex problems in connection with civil service administration. They were also directed to make such recommendations as they deemed fit so that the legislation, which has to all intents and purposes been in effect since 1919 when introduced by Sir Robert Borden, could be brought up to date, removing anomalous sections, if there be such. In general they were asked to make such recommendations as would generally be beneficial in assuring and maintaining the capacity and ability to serve of the civil service. Whatever may be the views with regard to the recommendations made, I am sure that everyone in the house will want to pay tribute to the commission for the work it has done and for the long hours and the devoted attention given by the members of this commission to this very intricate subject.

I am also tabling two copies in mimeographed form of the French translation of the report. This French translation, however, does not contain the appendices shown in the printed copy in English. The printed copies in French containing the report and the appendices will be available from the queen's printer in about two weeks' time and will then be placed before the house. In view of the interest in this subject, however, I thought it well that the recommendations be made available to hon. mem-

bers of this house. The appendices are merely an amplification in general of the principles and recommendations enunciated in the report. I should like to mention that copies of the report will be placed in the members' mail this afternoon.

The Prime Minister said that action of mine had prevented consideration. I put on the order paper a motion that was not debatable and I took the only course possible to make it debatable.

Mr. Diefenbaker: A moment ago the Leader of the Opposition asked me a question respecting the "Canadian Economic Outlook for 1958". I find, sir, that the motions are not far enough in hand to enable my hon. friends to have that economic report for this debate.
