QUEBEC—TELEGRAM FROM FEDERAL MINISTERS RESPECTING GRANT ALLOCATION

On the orders of the day:

Right Hon. J. G. Diefenbaker (Leader of the Opposition): Mr. Speaker, I should like to direct a question to the Minister of Industry asking whether the most unusual action taken by him and the Minister without Portfolio (Mr. Turner) yesterday in connection with the government of Quebec, as to what that government ought to do in the field of education, however justifiable the objectives were, was taken as members of the government or on their own?

Hon. C. M. Drury (Minister of Industry): Mr. Speaker, if I may speak on behalf of myself and my colleague, a telegram was sent jointly by myself and the member of parliament for St. Lawrence-St. George as members of parliament for two ridings on the island of Montreal, to two members of the provincial legislature from the island of Montreal, to seek to obtain their assistance in finding out whether something can be done for the university of which I am a graduate.

Mr. Diefenbaker: Was that done with the approval of the cabinet or did the minister do it on his own? No matter how justifiable the objective, does the minister think this is constitutionally proper?

Mr. Drury: Perhaps this is slightly argumentative—

Mr. Diefenbaker: No, it is not argumentative; it is factual.

Mr. Drury: —but I do think it is constitutionally proper. As I explained to the right hon. gentleman, this telegram was sent and signed by me in my capacity as a member of parliament and a graduate of McGill university.

Some hon. Members: Hear, hear.

Mr. Starr: You are a member of the cabinet. Have you got a dual role?
