Hon. Robert K. Andras (Minister of Manpower and Immigration): Mr. Speaker, the International Nickel Company has advised officials of my department that production cutbacks are not anticipated at this time in the Sudbury area. Consequently, no lay-offs are expected. I am assured by company officials that press reports regarding expected lay-offs and cutbacks are entirely without foundation.

Mr. Rodriguez: On a point of order, Mr. Speaker, I did not ask the minister about lay-offs but about work force levels.

Mr. Speaker: Order. I hope we do not get involved in another point of order. The hon. member might like to ask a supplementary and he will be recognized for that purpose, following which I will recognize the hon. member for Richmond.

Mr. Rodriguez: In view of the fact that I did not ask the minister about lay-offs but about projected employment and production levels, would the minister please answer the question?

Mr. Andras: Mr. Speaker, I will take the hon member's representation under advisement and reply later.

Hon. Robert K. Andras (Minister of Manpower and Immigration): Mr. Speaker, an unemployment insurance benefit recipient can be disentitled to unemployment insurance if he is not fulfilling his obligations under the act. The benefit control operation, as I indicated in a statement several weeks ago, when it goes into operation involves a personal interview, but there can be disentitlement arising from other reasons.

POSSIBLE USE OF PUBLIC RELATIONS FIRMS TO PUBLICIZE WHITE PAPER ON POLICY RATHER THAN GOVERNMENT AGENCY

Forrestall (Darmouth-Halifax East): Mr. Speaker, may I address a question to the Minister of National Health and Welfare having to do with whether or not the minister or his office in a very direct way have engaged a number of public relations firms across the country for the purpose of publicizing his release tomorrow of the white paper on welfare policy. If this is so, why did the minister's office not use the existing instruments within the government service for this purpose?
