**Hon. C. M. Drury (Minister of Public Works):** Mr. Speaker, as I think the House is aware, the Bank of Canada is a semi-autonomous agency and does not come under the administrative jurisdiction of the Department of Public Works. In this instance, this particular bank has not sought our advice.

**FRESHWATER FISH MARKETING CORPORATION****THREAT OF WITHDRAWAL BY MANITOBA—DISCLOSURE OF
