- (b) Individuals may if they wish borrow to invest in a limited partnership.
- (c) It is the intention of the government to encourage investment in R & D through tax incentives. The booklet explains how these incentives may apply to limited partnerships.

CUSTOMS TARIFF

MEASURE TO AMEND

On the Order: Government Orders:

January 28, 1982—Second reading and reference to a Committee of the Whole of Bill C-90, an act to amend the Customs Tariff and to repeal certain acts in consequence thereof.

Hon. Marcel Lambert (Edmonton West): Madam Speaker, I rise on a point of order concerning Bill C-90. This bill arises out of a Ways and Means motion dealing with the Customs tariff. I should like to include in my point of order a question to the Minister of State for Finance (Mr. Bussières), but first I should like to explain how it arises. Paragraphs Nos. 20, 21 and 22 repeal The New Zealand Trade Agreement Act, 1932 and The New Zealand Trade Agreement (Amendment) Act, 1970-71-72. Then paragraph 22 reads as follows:
