REDUCTION IN SUNCOR TAX PAYMENTS—APPLICATION OF RESTRAINT GUIDELINES

Mr. Paul E. McRae (Thunder Bay-Atikokan): Madam Speaker, my question is directed to the Minister of Energy, Mines and Resources. Yesterday he announced a \$35.5 million reduction in taxes to Suncor for additional spending for upgrading, efficiency and more production. Did Suncor give any undertaking that it would fulfil the six and five proposition?

Hon. Marc Lalonde (Minister of Energy, Mines and Resources): Madam Speaker, I am indeed very happy to see Suncor proceeding with a \$690 million investment, about half of which will take place in Ontario and the other half in Alberta. In return for the tax concessions granted by the Government of Canada, Suncor has agreed to adhere, within its own operations, both to the federal government's six and five wage guidelines, except for existing contractual obligations, and to the guideline respecting lower price increases during the next two years as the rate of increase in costs goes down and profit margins are restored as a result of the excellent budget presented by the Minister of Finance at the end of June.
