## CANADIAN COMMERCIAL BANK—COMMITTEE EXAMINATION

Mr. Simon de Jong (Regina East): Mr. Speaker, my question is to the Minister of State for Finance. Given what we have just heard from the Government House Leader that the Government is anxious to move the question of the CCB into committee, and given the fact as well that the committee's report on the CCB is just riddled with statements that the committee could not complete its report because it did not have access to the proper information and that the Inspector General of the Banks was not forthcoming with information, how can she expect the committee to get to the truth of the matter if all these documents and information are not fully available to the committee?

Hon. Barbara McDougall (Minister of State (Finance)): Mr. Speaker, I have indicated that I will give every document to the committee that I am legally entitled to give them. I have offered to break down the categories of depositors in a way that should meet their satisfaction about the legitimacy of these claims. We are working through other channels to attempt to get the report from the Federal Deposit Insurance Corporation in the United States. We have bent over backwards to indicate that we will provide the committee with this information.
