Mr. Svend J. Robinson (Burnaby—Kingsway): Mr. Speaker, I will be brief. Your Honour is aware of the fact that I was seeking the floor prior to the intervention by the government House leader and on the point to which Your Honour indicated he wishes to reserve.

## DISTURBANCE IN GALLERY
