#### **CRIMINAL CODE**

MEASURE TO AMEND

Mr. Peter Milliken (Kingston and the Islands) moved for leave to introduce Bill C-228, an act to amend the Criminal Code (mental disorder).

He said: The purpose of this bill is to update the provisions of the Criminal Code with respect to mentally disturbed accused persons. The bill is, in fact, not of my own authorship. It was one that was proposed in a white paper prepared by the Minister of Justice about three years ago. The hon. member for St. John's East was the Minister of Justice at that time, which gives some indication of the age of the document. But nothing has been done on the issue since that date.

The bill is introduced for the purpose of moving this issue along with some speed. I would hope that the government might consider referring the bill to a committee so that it could be studied there and enacted at an early date. This might assist the government in its dealings with these persons as a result of the Supreme Court of Canada's recent decision on this issue.
