Read second time, considered in Committee of the Whole; reported amended, considered as amended, 345. Motion for third reading; amendment proposed by Mr. Casgrain; negatived; Bill read third time; passed, 361. Passed by Senate with amendments, 486. Agreed to, 548. Royal Assent, 630.—62-63 Victoria, Chapter 34.
2. Bill (No. 178), An Act respecting the Quebec Harbour Commissioners; presented: Mr. Fielding, 711. Read second time, 776. Considered in Committee of the Whole; reported; read third time; passed, 786. Passed by Senate, 846. Royal Assent, 847.—62-63 Victoria, Chapter 35.
