**Mr. Ralph E. Goodale (Parliamentary Secretary to President of the Privy Council):** I am informed by the Departments of Post Office and Public Works as follows: 1. Total number of employees, 16,223; Estimated payroll for 1976-77, \$228.4 million.

2. Value of property—See answer to Part 2 of Question No. 1,620 answered April 1, 1977. Total cost of mechanization equipment installed for letters and flats processing and owned by Canada Post is as follows: Installed, \$3,493,300; In process of installation, \$14,060,000; Total, \$17,553,300.

In so far as the Department of National Defence is concerned: 1. Soviet Military Attachés must file a "Notice of Intent to Travel" forty-eight hours in advance of any journeys outside the National Capital area except for trips to Montreal where only twenty-four hours advance notice is required. The number of Soviet Military Attachés who have filed notices in the periods specified is: (a) Five; (b) Five; (c) Five; (d) Seven; (e) Eight.
