

MEMORIAL SERVICE AT NEWCASTLE

Fine Tribute to Worth of Late Major Belyea—Military Men Parade to Church.

Newcastle, April 8.—Newcastle United Baptist church was crowded to the doors yesterday afternoon, when a service was held in commemoration of Major W. H. Belyea, second in command of 8th Battalion, C. E. F., born August 9, 1877, killed in action March 30, 1916, in fighting for King and country upon the battlefields of Flanders.

Thursday, April 6. With a bullet wound through the calf of his leg, received in a riot on board ship, a member of the crew of the Norwegian steamship Thors was taken to the hospital last night. Other sailors showed marks of the fray which was only subdued when Captain Hanson exerted his authority and used his revolver. The steamer is lying at the Sugar Refinery wharf and the trouble had been going on, more or less, during the day. It assumed its more serious aspect at a late hour last night when some of the Moncton men on board the ship, who had been working on the ship, were seen to be in a state of excitement. The trouble was not, however, serious, and the captain, after using other efforts to bring the men under control, the captain had recourse to the only means left and drawing his revolver, threatened to shoot. Brief Despatches.

New York, April 8.—About 1,000 men, mostly unskilled laborers and timbermen employed on the city's new dual subway system went on strike today for an eight hour day and an increase of from 15 to 25 per cent in wages.

Buffalo, N. Y., April 8.—Twenty-five men were injured, five probably fatally, in an explosion at the plant of the Otis Elevator Company here today. The accident was attributed to the explosion of a gas tank in the foundry.

Grand Rapids, Mich., April 6.—Mrs. Clara Louise Peck Waite today filed suit for divorce in the superior court here against her husband, Dr. Arthur Warren Waite, of New York, who has confessed to the murder of her father and mother, Mr. and Mrs. John E. Peck, and is under indictment for murder in the first degree.

Halifax, April 5.—Missing his step on the deck of the steamer Scotsburn at De-Walt's wharf, Thomas Johnson, a fireman on the cable ship Hilda, fell overboard today and was drowned. Strenuous efforts were made by men on the steamer to rescue the man, but they could not reach him, and he sank before their eyes and almost within their grasp. He was fifty years of age and unmarried.

Charlottetown, April 8.—It is understood that the Steam Navigation Company has sold the Northumberland which has been plying on the Charlottetown-Pictou route to the Dominion government to run between Summerside and Point du Chene. Their other boat the Empress, has been sold or about to be sold to private parties.

Port Charles, N. Z., via London, April 8.—The Shackleton Antarctic auxiliary exploration ship Aurora has arrived here. All on board the ship are well, except two members of the crew who are suffering from a minor illness. Having been obliged to leave Ross Sea, the rendezvous agreed upon, before the arrival of the Antarctic explorer the Aurora brings no news of the expedition.

Norfolk, Va., April 5.—The schooner Elsie A. Bayles, of Bangor (Me.), went ashore early this morning near New Inlet (N. C.), coast guard station. Captain Brown was drowned while attempting to reach shore in a small boat. Two of the crew who were with him landed safely.

Chicago, April 5.—Practically complete returns today from points where the prohibition question was voted upon in Illinois indicate that little advantage went to either side as the result of yesterday's election.

Paris, April 5.—Guglielmo Marconi has invented a special apparatus, based on a new principle, which is designed to make a sensational change in the operation of aeroplanes and dirigibles. This announcement has just been made, according to a home despatch to the Journal des Debats.

Marconi has, at the same time, carried on important wireless telegraph researches with great success. His inventions will be immediately employed by the Italian army, after which they will be placed at the disposal of Italy's allies.

Louisville, Ky., April 6.—"I shot papa to put him out of my misery; it was an act of mercy," hysterically explained Anna Lee Stitzel after she had fired a bullet into the breast of her father, William Stitzel, aged seventy-five, a federal veteran of the civil war, at their home here last night. Mr. Stitzel died thirty minutes later.

For several weeks Miss Stitzel is said to have brooded over her father's loneliness and growing infirmity. Physicians who have attended the young woman believe she is suffering from dementia.
