

## INDIAN QUESTION IN VEXED STATE

Votes for Kenya Indians Bring  
Opposition From African  
Whites

LATTER TO SEE SMUTS  
Africans Feel Canada Does Not  
Understand Full Difficulty  
of Case

LONDON, August 31.—(Canadian Press Cable)—Reuter's agency has been officially informed that there is no foundation for the report that the secretary of state for the colonies has made important decisions affecting the enfranchisement and other questions connected with the policy regarding the natives of India who are now inhabitants of the Kenya colony of Eastern Africa. It is now understood that the general question of Indian policy will remain open until Major-General Sir Edward Northey, the governor-general of the Kenya colony, has returned from Kenya.

The status of the Indians in Kenya colony, as well as that of their fellow countrymen in British Columbia and other parts of the British dominions, was one of the thorniest subjects discussed at the recent conference of the premiers of the empire. It has now reached a stage which seriously affects imperial politics.

### WHITES TO SEE SMUTS.

A deputation of leading white settlers from Kenya has arrived at Beltra, in Portuguese East Africa, on their way to Pretoria to confer with Premier Smuts on the subject. This deputation is most emphatic in its view that the settlers of Kenya are prepared to do their utmost in opposition to the application of the principle of equality for the white and brown races in their colony, and it is not improbable that the conference with Smuts will embrace the whole question of Indian immigration and the supposed impossibility of granting equal constitutional rights to Asiatics in any part of Africa. The Kenya settlers interviewed at Beltra feel that the acquiescence of the Canadian and Australian prime ministers, in the resolution adopted by the imperial conference in favor of conferring citizenship upon the Asiatics in the dominions, is one understandable from the fact that Canada is too cold to attract large bodies of immigrants from India, while Australia is too far away to suggest trouble on that score. General Smuts, who arrived in Cape Town yesterday, will, therefore, be plunged into a new field for his abilities as a conciliator.

## U. S. AND JAPAN WILL SETTLE YAP QUESTION

Japanese Foreign Office Says Washington Will Recognize Jap Mandatory.

TOKIO, August 31.—(Associated Press Cable)—The Japanese foreign office has received advice, according to Tokio newspapers to-day, indicating that the points at issue between Japan and the United States over control of the Island of Yap would soon be settled upon the following basis:

First: The United States would recognize the Japanese mandate over that island.

Second: The United States would control the cable between the islands of Yap and Guam.

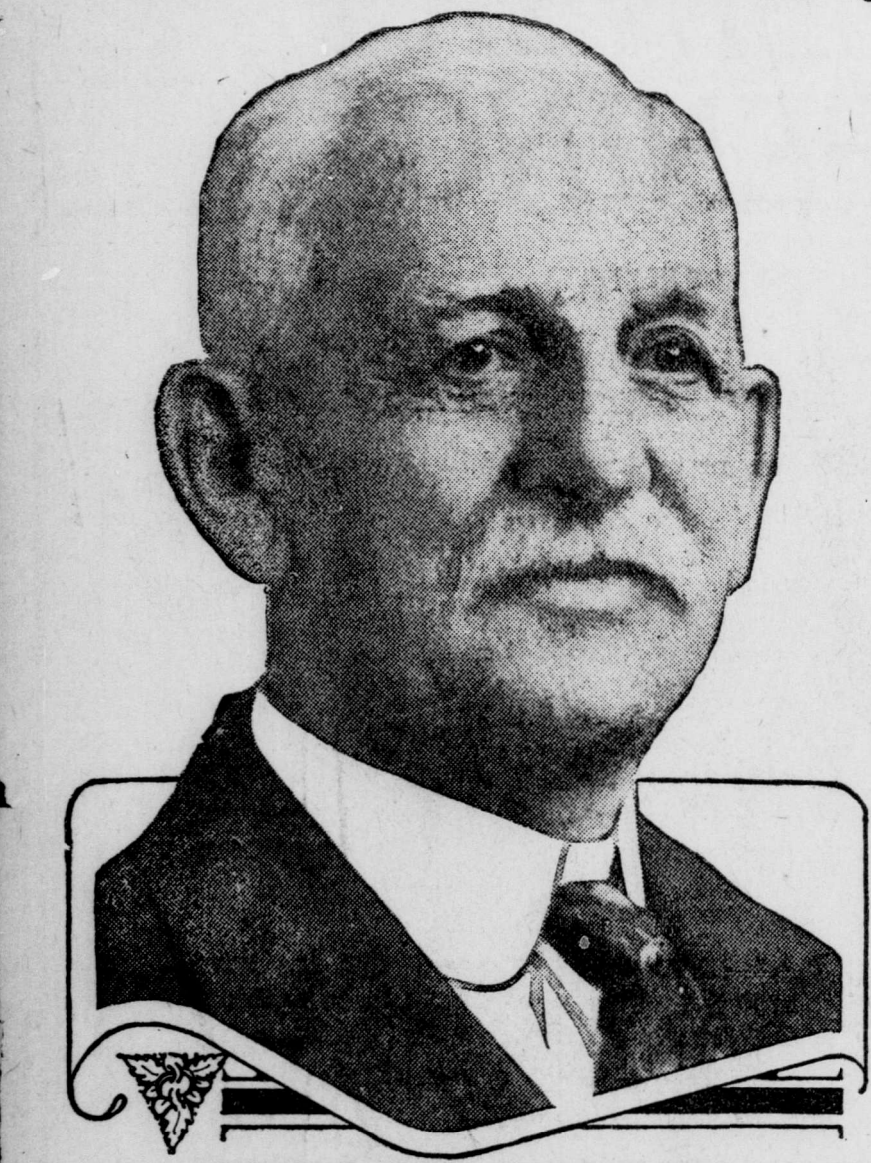
Third: The cable connecting Japan, Yap, and Menado, Holland, would be settled on a basis of recognition of Holland's rights therein.

## TWO DROWN WHEN BIG MAIN BURSTS

50,000,000 Gallons of Water Let  
Loose in Detroit Park

DEAD WERE IN A TRENCH  
Most of East Side of City Deprived of Water Supply

DETROIT, August 31.—(Special to The Free Press).—Two workmen lost their lives when a water main in Waterworks Park burst this afternoon, pouring 50,000,000 gallons of water into the park, submerging half its area, depriving most of the east side of its water supply and driving persons in the park helter skelter for high grounds. The dead are John Georgeoff, aged 45, and Steve Sietroff, aged 25.

Fire engineers have been set to work pumping water out of the park. The men drowned were in a gang of 22 engaged in laying a new main. The trench in which they were working was 12 feet deep. At 4:40 p.m. a joint in an old 48-inch main, running beside the new one, gave way. A torrent of water rapidly filled the trench. Workmen and passers-by threw ropes to those in the trench and pulled them out, all escaping but Georgeoff and Sietroff, whose bodies were recovered later.

The center of Waterworks Park is a depression, extending from Jefferson avenue across the park to the pumping plant and west between the two ponds. Half an hour after the main burst all this was flooded, the water being six feet deep in places. The high ground served as a dam to keep it back from the street. Persons in the park saw the water billowing out of the ditch and ran to safety. Their benches floated off among the trees.

The shouts of spectators failed to disturb one man who was sleeping on a bench. Finally a policeman waded out and shook him out of his dreams.

## JUSTICE CLUTE DIES AT TORONTO

Member of Ontario Supreme  
Court Was Long Ill

WAS BORN NEAR PICTON

Was Appointed to the Bench in  
February, 1905

TORONTO, August 31.—(Canadian Press Dispatch).—Hon. Roger Conger Clute, 19 Walmer road, a judge of the Supreme Court of Ontario, at Osgoode Hall, died this afternoon after a long illness in his 73rd year. Of United Empire Loyalist stock, Mr. Justice Clute was born near Picton on August 13, 1844, and educated at Sterling Grammar School and Albert College, Belleville.

In June, 1873, he married Rosa, daughter of the late Henry Corby, of Belleville. He was called to the bar in the same year and became a K. C. in 1890. He practiced his profession at Belleville, and often was crown prosecutor. He went to Toronto in 1903.

CANDIDATE FOR COMMONS.  
He was an unsuccessful candidate in the Liberal interest in West Hastings for the Commons in 1921, and was elevated to the bench in February, 1900.

He was a royal commissioner on several occasions, notably in 1899, regarding miners and mine owners in British Columbia, and in 1900 relative to Chinese and Japanese immigration into Canada. In 1906 he imposed a fine of \$10,000 upon the Central Supply Association and the Master Plumbers' Association on a charge of conspiracy.

A man of strong personality, he declined to receive a congratulatory address from the bar on his appointment to the bench. In religion he was a Presbyterian. He is survived by his widow, one son, Arthur R. Clute, barrister, and one daughter, Mrs. William Lucy, of Devonshire, England.

## INJUNCTION TIES UP MENNONITES' CROPS

American Syndicate Secures Order  
From Court Forbidding Sale of  
Grain.

REGINA, Sask., August 31.—(Canadian Press Dispatch).—Mennonite communities in Saskatchewan, where lands

are involved in litigation as the result of the deal for the purchase of large Mennonite holdings by an American syndicate, will be unable to dispose of their 1921 crop until the pending lawsuits have been determined.

This result follows the granting yesterday of an application for Justice MacKay in the court of King's bench by Bram Thomson for an injunction restraining the Mennonites or anyone else

from selling any portion of the Mennonite crops now being harvested. It is estimated that a million bushels of grain will be held up as a result of the order.

SHOOTING AT HAMILTON.  
HAMILTON, August 31.—Mrs. Lucia Szzo, aged 32, was shot and probably fatally wounded to-day as the result of a family quarrel. Her brother-in-law, Pepino Catelli, is being sought by the police. He is said to have fired the shot.

## LOTTERY SCHEME TO ENDOW MOTHERHOOD

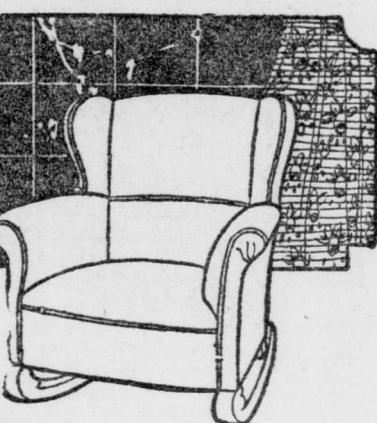

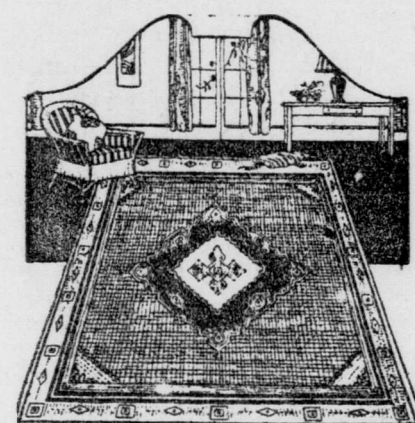
## CONTROLLER MAY BE SERIOUSLY INJURED
