#### HOUSING CONDITIONS OF ESKIMOS

# Question No. 1,714-Mr. Orlikow:

1. Have surveys been made of housing conditions available to the Eskimos of Canada's north and, if so, what percentage of the Eskimos are living in houses considered to be substandard and detrimental to the health of the occupants?

[Mr. Latulippe.]

2. Has any federal government department made plans for an aggressive program of building new housing accommodation for Eskimos designed to check the serious health hazards caused by inadequate housing?

Mr. Laing: 1. Yes. As of March 31, 1963, it is estimated that about 2,000 Eskimo families were in need of better housing. The total Eskimo population is estimated at 12,000.

2. Yes, (a) through departmental initiative, since 1959, some 400 houses have been sold to Eskimos, and some 300 provided to other Eskimo families who are unable to pay for such houses; (b) a continuing program to improve designs and techniques of construction has cut costs and provided Eskimos with better houses for less money; (c) water and sewer services have been improved as part of a continuing program to provide adequate sanitary facilities.

#### EXPORT CREDIT INSURANCE

### Question No. 1,719-Mr. Scott:

1. Is the government presently reviewing its export finance and insurance machinery and, if so, along what lines is the review being conducted?

2. Have there been requests that the provisions of the export credits insurance corporation be applied to transactions under \$2,000,000 and, if so (a) how many such requests have there been (b) what products were covered (c) who made the requests, and (d) what was the nature of the government's replies?

3. What amount of export insurance was handled by private insurance companies in 1960, 1961, 1962 and 1963 to date, and what ratio does this bear to export insurance handled by the export credits insurance corporation?

4. Has the government given consideration to providing export credit insurance to exports to the U.S.A. and, if so, what was the nature of such considerations?

Answer: 1. Export Credits Insurance Corporation continually reviews its export finance and insurance machinery. This is also reviewed by interdepartmental committees and ministers are kept informed of any changes which might be required.
