#### TAX REVIEW BOARD BILL

ESTABLISHMENT, DUTIES, APPEALS, ORGANIZATIONS, ETC.

The House proceeded to the consideration of Bill C-174, to establish a tax review board and to make certain other

amendments to other acts in relation thereto, as reported (with an amendment) from the Standing Committee on Justice and Legal Affairs.

**Hon. John N. Turner (Minister of Justice):** I move

That Bill C-174, an act to establish the Tax Review Board and to make certain amendments to other acts in relation thereto, be amended by striking out line 13 of subclause 22(3) at page 13 and substituting the following:

On page iii at the back of the order paper, will be found a revised recommendation. This was inserted at my request. It was done after there had been certain consultations, to meet the point raised by the hon. member for Edmonton West (Mr. Lambert) on second reading. I think there would be some disposition in the House to allow that recommendation to be changed by unanimous consent. Perhaps the amendment that has just been put might then be considered.

**Mr. Speaker:** Hon. members have heard the suggestion made by the Minister of Justice. Is this agreed?

**Some hon. Members:** Agreed.

**Mr. Turner (Ottawa-Carleton):** Mr. Speaker, since the recommendation has now been so amended, may I say that this particular amendment was suggested in committee by the hon. member for London West (Mr. Buchanan), I think. The committee agreed unanimously. Obviously, a minister's approval was necessary because this matter affects ways and means. I have agreed. This amendment reflects the unanimous decision of the committee. You will notice that the recommendation has to be amended accordingly.

Motion (Mr. Turner, Ottawa-Carleton) agreed to.
