FEED GRAINS POLICY—INQUIRY AS TO WHETHER DECISION MADE ON RETENTION OF CONTROL BY WHEAT BOARD

Right Hon. J. G. Diefenbaker (Prince Albert): Mr. Speaker, my question is supplementary to questions asked some time ago of the Minister of Agriculture. I would ask him whether or not the cabinet has made a decision concerning exclusion of feed grains from the Canadian Wheat Board. Has there been any such decision made?

Hon. E. F. Whelan (Minister of Agriculture): Mr. Speaker, as I said to some other members, the decision and announcement will be made by August 1.

Mr. Diefenbaker: Mr. Speaker, a simple question like that should be answered clearly. If the government pretends that no decision has been made I should like to ask the minister what will be the nature of the discussion he is to have in Prince Edward Island in connection with feed grains?

Mr. Whelan: Mr. Speaker, I have been invited to attend the meeting. It is not my meeting in Prince Edward Island. I am invited to attend the meeting of provincial ministers of agriculture from all across this land. They are to make their suggestions and requests to me. I am to be there to listen, but you can be sure that will not be all I will be doing there.

Mr. Speaker: Order, please. The Chair will recognize the right hon. gentleman for a supplementary, but again I ask for co-operation of members because there are only two minutes left before the end of the question period.

Mr. Diefenbaker: This is a question which affects western Canada to a degree no other matter does.

Some hon. Members: Oh!, oh!

Mr. Diefenbaker: Mr. Speaker, you will notice how the Liberal members ridicule western members by their attitude.

Mr. Speaker: May we have order, please. Perhaps the right hon. gentleman might ask a question now. We are running short of time.

wheat pools in western Canada to ascertain their suggestions and will they be listened to, too?

Hon. E. F. Whelan (Minister of Agriculture): Mr. Speaker, this is a very important question which the right hon. gentleman has asked, and I want to say that the Minister of Agriculture for Canada is concerned about the interests of all farmers of Canada. It will be my concern, as it is the concern of the government, to make sure that all farmers in Canada, wherever they may be, those who use feed grain or not, will be treated in an equitable fashion. This is my job as a member of the government and I understand it is government policy to listen and consult. I have discussed this with members of the wheat pools of the three provinces and leaders of farm organizations. I know some of their views. They are not all opposed. All have different views. We are also listening to the provincial governments, and I certainly cannot say so far that they are unanimous in their feelings about what should be done in respect of a feed grains policy.
