CONSTRUCTION OF QUEBEC-MARITIME GAS LINE PROJECT

Miss Coline Campbell (South West Nova): Madam Speaker, my question is directed to the Minister of Energy, Mines and Resources and relates to the cabinet decision to go ahead with the construction of a Quebec-Maritime pipeline. Could the minister advise the House whether or not there has been any support for this decision by either the government of New Brunswick or the government of Nova Scotia?

Hon. Marc Lalonde (Minister of Energy, Mines and Resources): Yes, Madam Speaker. During the last few months, I have been very happy to see that the government of Nova Scotia and the government of New Brunswick have been eager to see the approval of this very important project for the maritime provinces. It was with great pleasure that the cabinet took the decision to approve the recommendation of the National Energy Board to proceed with the extension of the gas pipeline across Canada, right through to Halifax. It is now a matter of ensuring that the necessary regulatory approvals take place in each of these provinces, including Quebec, New Brunswick and Nova Scotia, in order to see a speedy implementation of this project. As far as the Government of Canada is concerned, we are fully behind this project and we want to see it implemented as soon as possible.
