PUBLIC SERVICE 2000

Mrs. Marlene Catterall (Ottawa West): Mr. Speaker, the government's white paper on Public Service 2000 tabled yesterday confirms the concerns of the Liberal Party and Public Service employees that real consultation is not part of the agenda of the government.

The document was prepared without consultation with employee representatives and far from being a discussion paper, it is riddled with dictates like "the government will", "the government has decided", "the government will require". There is no strategy in place for a dialogue. In fact the President of the Treasury Board has sent out mixed messages about whether the paper will even be referred to a special committee as recommended by the public accounts committee.
