As far as I am concerned, I ran as a Conservative and in spite of my faults, I remain a Conservative, because I am a man of my word. I respect the commitment that I gave to Quebecers, just like those who were elected as Liberals have respected their commitment, and similarly for the New Democrats. Mr. Edmonston respected his commitment to Quebecers. Those who refused and went back on their formal commitment—

## WEEKLY STATEMENT

**Mr. David Dingwall (Cape Breton—East Richmond):** Mr. Speaker, my question is to the government House leader. Would he indicate to the House the business for tomorrow as well as for Monday and Tuesday and the remaining days of next week.

**Hon. Harvie Andre (Minister of State and Leader of the Government in the House of Commons):** Mr. Speaker, the House will complete third reading of Bill C-81, an act to provide for a referendum for the Constitution of Canada, this afternoon.

I would like to formally designate tomorrow, Friday, June 5, as an allotted day. Monday the government will call Bill C-41, the Energy Emergency Act, for completion of report and third reading; Bill C-78, an act to amend certain acts with respect to persons with disabilities, for second reading. Hopefully we will begin report stage of Bill C-22, an act to amend the Bankruptcy Act.

On Tuesday, June 9, we will hopefully complete second reading of Bill C-80, an act to amend the Income Tax Act, to enact the children's special allowances act.

I will be in discussion with my colleague and the New Democratic Party's representative in terms of business for the rest of next week.
