### PRICE MOVEMENTS CONFUSED ON THE STOCK EXCHANGES TODAY

#### SHORT COVERING IMPARTS BETTER TONE IN N.Y.

Substantial Recoveries Are Made by General Motors

ACTIVE BUT SPOTTY ON MONTREAL MART

Chief Interest in Brazilian With Power Giving Exhibition of Strength

NEW YORK, Oct. 13.—Confusing price movements marked the resumption of stock market trading, with short covering imparting a better tone to the market. Allied Chemical rallied six points, and substantial recoveries were scored by General Motors, Woolworth and other prominent shares. Southern Railway resumed favorably to the news for a new stock offering and was followed upward by Atchafalaya and New York Central. Scattered selling was evident in the oil group.

MONTREAL, Oct. 13.—Trading during the first half hour on the local stock exchange this morning was fairly active, but spotty. Chief interest was again centered in Brazilian, and after opening unchanged, this issue moved down a quarter to 10 1/2. #### NAMES OPPONENTS TO HANDLE HELM

Columbia Owner Wants Morrissey as Skipper For Challenge Races

GLOUCESTER, Mass., Oct. 13.—Champion of this port's fishing fleet by virtue of two straight victories over the schooner Henry Ford, the sloop Columbia, sailed today in answer to the challenge that may send her into competition against the Canadian winner in the fishing fleet races off Halifax next Saturday.

Pine Pine, who steered the Columbia to victory yesterday, sang his own song as a racing skipper, when he brought his schooner into port, but generally named Captain Clayton Morrissey of the Ford, as his successor, should the Columbia enter the international contest.

Captain Ben sent the Columbia's challenge last night, and, if accepted, will mean the race will be held off this port the week of October 25. The international race has not been contested since 1925.

#### DECISIVE VICTORY.

Yesterday's victory of the Columbia, over the Ford, was even more decisive than on the previous day, when Pine's boat had nosed its way home by a bare minute and four seconds.

The Columbia led yesterday by nearly five full minutes. It was a battle of skipper to skipper, as the two boats were in a neck-and-neck race.

All the shipping in the harbor joined in a noisy welcome to the winner, and sooner had the competing schooners been ducked, but Pine and Morrissey refused to shake hands, and exchange congratulations. A hand met the racing crews at the wharf and victor and vanquished marched behind it while thousands cheered the way along the main street.

#### CONDEMNED MAN REPORTED SANE

John Buchan Pirie Anxious to be Deported to England, is Guelph Report

OTTAWA, Oct. 13.—A special to the Journal from Guelph says: "John Buchan Pirie, former Ottawa man whose slaying of Caroline Free-land, and their two children in the spring of 1924, stirred the whole province, is sane, according to eminent psychiatrists, who have had him under constant observation in the provincial institution for the insane here.

"Pirie is perfectly rational, according to the doctors. He is in the best of health, takes a great interest in things and is said to be anxious to be deported back to England.

"Pirie, who was sentenced to be hanged and who was saved by a commutation, received life imprisonment as punishment for the killing of his common-law wife, and their two children.
