How can the minister explain the high unemployment figures in the Atlantic area as compared with the rest of Canada and expect anything to be done about it through his policy if he will not allow the growth areas to increase and send out benefits to the whole region?

Certainly there have to be new concepts produced for the Atlantic area if we are to overcome the high unemployment rate which exists there at the present time, a rate three times as high as that for the rest of Canada. Beyond doubt if we are to get anything done in this regard through the minister's proposals the plan will have to include the growth areas of Halifax, Dartmouth, Saint John and Fredericton, as APEC and every economic organization in the Atlantic area have done. There is no other way in which this program could succeed.

I should like to talk about another aspect of this area development program, this designated area program as the minister calls it. The minister kindly consented to visit my home town one week prior to the election, and on that occasion he told my constituents that four new industries would be coming there. All this was through the designated
