fresh air. However as a result of the board's studies it was recommended that the tackle regulations be amended to govern the use of internal combustion engines used in cargo holds.

5. Section 63(3) of the tackle regulations, made under the Canada Shipping Act by order in council P.C. 1961-188 of February 9, 1961, provides that "where internal combustion engines are used in cargo spaces the carbon monoxide gas concentration shall not exceed 100 parts per million".

# VOTE BY CHAIRMAN OF LABOUR RELATIONS BOARD

### Question No. 246-Mr. Simard:

In the case of an inter-union dispute involving an affiliated member of the CLC and an affiliated member of the CNTU, must the CNTU and the CLC be represented in equal numbers, that is, two for the CNTU and two for the CLC?

Mr. B. S. Mackasey (Parliamentary Secretary to Minister of Labour): Every matter coming before the board is dealt with on its merits by the board as a whole without distinction as to the nature of the issue involved.
