YOUTH

OPPORTUNITIES FOR YOUTH PROGRAM—AGREEMENTS WITH QUEBEC AND OTHER PROVINCES—REQUEST FOR REPORT ON 1971 ACTIVITIES AND 1972 PLANS

Mr. David MacDonald (Egmont): My question is for the Secretary of State. It concerns the announcement last week by the Minister of Education in the National Assembly of Quebec relative to a number of agreements concerning next year's Opportunities for Youth program. Can the minister indicate whether there has been a final or even an intermediate agreement with the government of Quebec and whether such consultations and agreements exist with other provinces? Also, in view of the late date when may we expect to hear some report on this year's program and some statement with regard to next vear's plans?

Hon. Gérard Pelletier (Secretary of State): Mr. Speaker, the hon. member is right in saying "agreement" since, in fact, there has not been any formal agreement with any of the provinces visited, that is, neither with Nova Scotia, New Brunswick, Prince Edward Island, nor with Quebec. This is where we stand in our consultations. We propose to them a certain number of ideas; some of these seem interesting to them, and they accept them; others are rejected, and we do likewise on our side. We speak all the less firmly that the pursuit of the Opportunities for Youth program has not yet been the subject of any final decision.

As for the report, I apologize to the House for the delay in tabling it, but this is a matter of data processing and the task force responsible for producing the report is working very hard at this.

As for deadlines, we will be meeting them much better this year than we did last year, if it is decided that the program should be taken up again under the same form as last year.
