In view of the last mass murder in which 13 victims died as a result of setting fire to "Le Gargantua" nightclub in Montreal, and the fact that this barbaric act is part of a new wave of murders and violence in this country, I move, seconded by the hon. member for Lotbinière (Mr. Fortin):

That the House of Commons discuss immediately the possibility of reinstating capital punishment as possible sanction in the case of manslaughter in order to bring under control a situation which has now become intolerable.

PROPOSED SUSPENSION OF CONSTRUCTION OF PRIME MINISTER'S SWIMMING POOL UNTIL NAMES OF DONORS REVEALED—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43

Mr. Tom Cossitt (Leeds): Mr. Speaker, I rise under the provisions of Standing Order 43 to ask permission to move a motion on a subject that has been touched on by the hon. member for Winnipeg North Centre (Mr. Knowles). It is an entirely different approach to the subject. Therefore, I feel there is not in any way a duplication. I ask permission to move, seconded by the hon. member for Parry Sound-Muskoka (Mr. Darling):

In view of the urgent and pressing necessity of establishing whether or not any improprieties or conflict of interest factors exist in connection with construction of a swimming pool at the Prime Minister's residence at 24 Sussex Drive, the House requests that such construction be suspended and not continued further unless or until the Prime Minister makes a detailed statement to parliament on all circumstances surrounding this situation, including full revelation of the identities of all persons involved in anonymously furnishing very substantial sums of money to the project, all reasons and purposes such money is being furnished and whether or not any public funds are included in the reported total minimum expenditure of \$200,000.

Mr. Speaker: The House having expressed a lack of unanimous consent to debate a motion presented by the hon. member for Winnipeg North Centre (Mr. Knowles) under very similar terms, I can only conclude there would be an expression of the same sentiment with regard to this motion.
