TOMATOES—EFFECT OF IMPORTS ON CANADIAN GREENHOUSE TOMATO PRODUCERS

Mr. Robert Daudlin (Kent-Essex): Mr. Speaker, my question is for the Minister of Agriculture. Is the minister aware that the imports into the Canadian market of Florida field tomatoes and Cleveland greenhouse tomatoes have so far despressed the price on the Canadian market that Canadian greenhouse tomato producers are being forced to sell their produce, which is only now reaching the height of its season, at a price below the cost of production? If so, what steps is he taking to protect the Canadian greenhouse industry?

Hon. E. F. Whelan (Minister of Agriculture): Mr. Speaker, we are well aware of the fact that tomatoes from Mexico and the United States have been brought into Canada. There is no substantial increase in the amount of tomatoes which have come here. We think the present situation is temporary because of crop conditions in Mexico and Florida, and we think the market will alleviate itself of this problem.

PICKERING—DATE OF OFFER TO RESIDENTS OF STOUFFVILLE TO PURCHASE HOMES

Mr. Sinclair Stevens (York-Simcoe): Mr. Speaker, my question is for the Minister of Public Works. In view of the minister's statement last week with regard to the future Pickering airport noise disturbance that an offer has been made for those residents in Stouffville who want to leave to regard the government as purchaser of last resort, would the minister indicate when the offer was made, to whom it was extended and in what form? It now appears no one in Stouffville has heard of the offer, including the mayor of that town.

Hon. C. M. Drury (Minister of Public Works): Mr. Speaker, the indication I gave in the House was, perhaps, imprecise in that the details of the offer have not been worked out, but the government will be prepared, as a purchaser of last resort to offer to purchase houses from citizens who wish to move away by reason of noise levels.

Mr. Stevens: Could the minister be more precise as to exactly when the government will be making this approach to the residents of Stouffville?

Mr. Drury: I think perhaps more in the way of details and more in the way of knowledge as to possible noise levels in the future should be worked out before the offer is communicated. Those who wish to avail themselves of this will want to know against what kind of test they will be operating.
