The Budget

The federal government is working in close co-operation with provinces, groups and social agencies. The costs of services provided to battered women are shared with the provinces through the Canada Assistance Plan.

In 1982, the Department of National Health and Welfare set up the National Clearing house on Family Violence.

The Clearing house collects, analyses and disseminates information on family violence; advises and assists professional and lay workers concerning training programs and research projects; organizes seminars and workshops, co-operates with other departments, governmental and non-governmental groups to identify current problems and prevent family violence.

Vis-à-vis, the bilingual newsletter published quarterly by the Clearing house is offered free of charge to the Canadian public. It contains surveys, annotated bibliographies, lists of resources, calendars of events and articles on current research programs and activities.

The collection of films on family violence comprises over 30 features made available free of charge to the general public and specialists through the distribution offices of the National Film Board throughout Canada.

In the area of day care centres in Canada, the federal Government has committed itself to promote the development of extensive, economical and good quality services. Again through the Canada Assistance Plan, the Government is sharing with the provinces the costs of child care services for families in need or likely to be.

FINANCE—BULK FUEL DEALERS—REIMBURSEMENT OF SALES TAX

Mr. Geoff Wilson (Swift Current-Maple Creek): Mr. Speaker, on Tuesday, April 30, 1985, I posed a question to the Minister of Finance (Mr. Wilson) concerning the fuel sales tax rebate to primary producers. Some bulk fuel dealers who hold tax paid inventory must seek reimbursement from the federal Treasury for sales tax not collected at the time of sale. The cost of financing the delay between the date of payment of tax by the bulk fuel dealer and the date of receipt of reimbursement of that tax from the Government is placing a burden on many dealers. I asked the Minister if he would examine the possibility of providing cash advances or floats to the dealers to alleviate this situation. I would like to elaborate on this matter.

Members will recall Bill C-12, put forth last fall, which provided among other things for a sales tax rebate of three cents per litre on the sale of fuel to primary producers, including farmers, fishermen and others, plus 1.8 cents per litre, being the petroleum compensation charge, for a total of 4.8 cents or almost 22 cents per gallon. This, to the primary producers, was a most welcome fulfillment of a campaign commitment.
