FINANCE AND ECONOMIC AFFAIRS—THIRD REPORT OF STANDING COMMITTEE

Mr. Don Blenkarn (Mississauga South): Mr. Speaker, I have the honour to present the third report of the Standing Committee on Finance and Economic Affairs, in both official languages. The report deals with the Economic Council of Canada. It makes recommendations in respect of how the council should operate and congratulates the Government on the appointment of Judith Maxwell as chairman of that council.

LABOUR, EMPLOYMENT AND IMMIGRATION—NINTH REPORT OF STANDING COMMITTEE

Mr. Jim Hawkes (Calgary West): Mr. Speaker, I have the honour to present the ninth report of the Standing Committee on Labour, Employment and Immigration, concerning family class immigration.

In accordance with Standing Order 99(2), I request that the Government make a comprehensive response to the ninth report. The report is long and complex. It deals with the whole issue of family reunification in Canada. However, its major theme is the suggestion that for high priority family reunifications, such as spouses and dependent children, we should be able to have a processing system which enables that reunification to take place in something less than two months in almost all cases, as opposed to the current seven months or eight months on average.

It also suggest that a new class be created called the assisted family class, which would encompass over age children,
