EXPORT DEVELOPMENT ACT

MEASURE TO AMEND

Hon. Lloyd Axworthy (Winnipeg—Fort Garry) moved for leave to introduce Bill C-316, an Act to amend the Export Development Act (commercial credits).

Mr. Speaker: Is it the pleasure of the House that the Hon. Member shall have leave to introduce the Bill?

This is a Bill designed to amend the Export Development Act, to provide for new commercial credits that would be given to Third World countries. The Export Development Corporation would act as a broker for the sale and exchange of commodities from Third World countries. The funds that would be gathered from such sales could then be used for purchases of Canadian products by those Third World countries in Canada. It is an attempt to provide a way of diversifying trade for Canada around the world and to provide direct assistance to Third World and underdeveloped countries in the sale of their commodities.

Motion agreed to, Bill read the first time and ordered to be printed.

POINT OF ORDER

TENTH REPORT OF STANDING JOINT COMMITTEE ON SCRUTINY OF REGULATIONS

Mr. Jim Hawkes (Parliamentary Secretary to Deputy Prime Minister and President of the Privy Council): Mr. Speaker, we were anticipating that the House of Commons cochairman of the Standing Joint Committee on Scrutiny of Regulations would move concurrence in the committee's tenth report. It is our understanding that it deals with the independence of the judiciary and a decision made by the committee.

I do not know if there is another agent in the Chamber who would like to move that motion, but the Government would certainly be willing to concur in it if someone wanted to move it.
