What You Should Do When

Anyone Is Bitten By a Dog

For the safety of children and others in a community all knowledge regarding mad dogs, rabies and hydrophobia must be put into real practice by everyone.

Rabies is an infectious, microbic disease. The microbe is in the mouth and saliva of the dog.

Latencies occurs once in a while between the throat and the wound.

Whenever there is any reason whatsoever to suspect that the animal directly or indirectly responsible for the wound may have rabies, aside from cutting and dressing the wound, arrangements should be made for the animal to be kept in a secure place.

If the animal is dead its head should be detached from the body and sent to a licensed veterinarian for examination of the brain for evidence of rabies.

If the animal is alive, every possible effort should be made to keep it securely confined and under observation for at least two weeks.

It is to be remembered that in the early stages of the disease the changes sought for in the brain, indicating the existence of rabies, are likely to be entirely absent.

If changes, known to occur in rabies in the brain or other parts of the nervous system are not found in an animal killed early in the course of the disease the saliva may have contained the virus at the time of biting, and the person bitten may be dangerously infected with the disease.

Further Precautions. When an animal has been a consequence of the disease, examination of the brain will readily reveal changes and make an accurate, early diagnosis possible. The saliva may contain the virus several days before the animal shows symptoms of the disease, and the bite of an animal at this time may result in the development of hydrophobia.
