REPORT OF THE COMMITTEE ON PETITIONS AND APPEALS.

Your Committee on Appeals beg leave to report upon the several matters submitted to them, as follows:

1. That the petition of L. O. L. No. 1230, Sarnia, to reinstate J_{0h}^{12} McIonis be granted; the same having been recommended by the Primary District and County Lodges.

2. That the petition of L. O. L. No. 297, Brantford, praying for the reinstatement of William Reeves, be granted, said petition having been recommended by the Primary, District and County Lodges,

3. Your Committee recommend that the petition of the District Lodge of Brock, praying that Robert Johnsson be reinstated, be granted. Your Committee, however, must place on record their surprise at, and disapproval of the hasty and ill considered action of the District and County Lodges in this matter.

 That the petition of L. O. L. 136, Toronto, praying for the reinstatement of John Smith, be granted, the same having been duly recommended by the Primary, District and County Lodges.

5. In the matter of the appeal of Thomas Hopwood against the finding of L. O.
