INVESTIGATING THE MURDER OF LUCY DENNING.

Random Andrew, his wife and daughter-in-law Arraigned on the Charge of Placing a Young Girl Who Had Been Taken Under the "Doctor's" Treatment.

"Dr." Random Andrew, Alice Andrews, his wife, and Cassie Andrews were yesterday put on trial for their lives in the Criminal Assizes.

The three are charged with having murdered Lucy Denning, a young woman who placed herself under the "doctor's" treatment. Justice Meredith presided. R. C. Clute represented the Crown, W. R. Ridgell, Q.C., defended Dr. Andrew, John McGregor Mrs. Alice Andrews and N. D. Mills Mrs. Cassie Andrews.

The Prisoners in the Dock.

"Doc" Andrew sat at the right of the witness box. He was an elderly man with a flowing beard whitened with years, dressed in a black cutaway, he leaned his head wearily on his hand and listened to the evidence.

Next sat Alice Andrews, his wife, a rather good-looking woman, hardly of middle age. She and Cassie Andrews, daughter-in-law of the doctor, were garbed entirely in black. Both wore hats of black, with dainty bunches of flowers ornamenting them.

LONDON, May 9.—The Board of Trade returns show that emigration to Canada declined from 8537 in April, 1893, to 3224 in April, 1894.

For the first four months of 1894 emigration to Canada declined 6233 from 18,259, the figures of 1893.

Emigration to the United States decreased one-half, but to Australia it increased slightly.

LIBERALS OF WEST TORONTO.

G. G. & LINDSEY THE CHOICE OF THE PARTY.

Convention at the West End Y.M.C.A. Hall Last Evening—All Other Candidates Retire in His Favor—Address by the Hon. Mr. Joseph Tait and Others.

The Liberal convention for the electoral division of West Toronto for the nomination of a candidate for the Provincial Legislature in the approaching general election was held last evening at the West End Y.M.C.A. Hall on the corner of Queen-street west and Dovercourt-road. The hall was well filled, about 250 delegates being present.

It was fully 20 minutes to 9 before Dr. Lynd, president of the West Toronto Reform Association, the chairman, opened the convention, the gathering meantime having become somewhat impatient at the delay.

These gentlemen occupied seats as follows: Messrs. G. G. Lindsey, Ex-Ald. Verall, W. L. Mackenzie, Dr. Hunter, Hugh McMaib, Dr. Sloan, George Evans, Robert Young, Hon. S. C. Biggs, Mr. Wingfield, T. A. Thompson, William Adams and John Mallon.

The chairman, in the proceedings in a short address, urged the necessity of sending a representative to sustain the Government. He explained that the convention was an equally important committee, representing the Reform Association, included in West Toronto. The choice of a candidate was entirely in their hands and no arrangement had been made. A period of 15 minutes would be allowed for nominations.

The Nominations.

Ald. Graham said it afforded him great pleasure to nominate G. G. Lindsey. Hugh McMaib in an equally brief speech seconded the nomination.

Other nominations made were as follows: Dr. Lynd by J. Nolan, seconded by Douglas Campbell; Hon. S. C. Biggs by James Tennant, seconded by Thomas Wilson; W. L. Mackenzie by Dr. Lynd, seconded by G. E. Ryan; J. M. Wingfield by Dr. Sloan; Frank Peddy by J. M. Sutherland and Sturgeon Stewart.

Nominations now came in thick and fast from all parts of the hall, among those being mentioned being Messrs. Benjamin Westwood, Dr. Hunter, J. C. Morgan, J. B. Hay, G. E. Ryan, Ald. Graham, W. H. P. Clement, George Evans and John Mallon.

Declared by the House. Brief addresses were made by J. C. Morgan, J. M. Wingfield, W. W. P. Clement, W. L. Mackenzie, John B. Hay, Verall and George Evans withdrawing from the contest in favor of Mr. Lindsey.

Mr. Westwood withdrew in favor of Mr. Lindsey, and Mr. Mackenzie, who had been nominated, also declared in favor of Mr. Lindsey.

Mr. Hunter said that he was glad to express confidence in a leader of the party who would take a conspicuous place and make his mark in the legislative hall. It was not sufficient to send an ordinary man to the Ontario Legislature.

Mr. Lindsey, in declining the nomination, said he thought the prospects of success must be gratifying to the party, and he hoped that on this nomination, instead of being, as formerly, a conservative force, it would be a fair fighting chance in at least three or four years.

He urged the perfecting of the organization, as was now being done in North and South Toronto. If the full strength of the party were brought to the front success would crown their efforts.

Hugh McMaib was satisfied that the right man had been chosen, and he expressed his confidence in Mr. Lindsey's nomination, in whose favor he retired.

Hon. S. C. Biggs was not a candidate and would do all he could to elect the nominee. Dr. Lynd, while glad to see a nomination, was not in a position to accept it. He retired in Mr. Lindsey's favor.

Mr. Lindsey's acceptance. This cleared the slate and Mr. Lindsey was declared the nominee by acclamation and loud applause.

Mr. Lindsey, in accepting the nomination, said there was only one thing that stood in the way, viz. the state of health, and he hoped that on this nomination, his supporters would relieve him as far as possible from the fatigue and excitement of the campaign.

He had been born and brought up among them, and it pleased him to see them, and if elected it would always be his object to keep Toronto's interests prominently in view. He had a double honor in being elected by the Reform Association and in being elected by the Liberal party.
