Mr. Drury: Mr. Speaker, I think an analysis of the scientific effort of Canada is now being made and a report thereon is likely to emerge soon in the Senate. I think it would be a little foolhardy to make a statement in anticipation of this being done.

INTRODUCTION OF AMENDMENTS TO FISHERIES ACT—BUSINESS FOR APRIL 6

While I am on my feet, perhaps I should indicate for the benefit of the House that upon our return on April 6 it is the government's intention to take as the first order of business Government Order No. 5, Bill C-3, an act to amend the Criminal Code.

ROYAL CANADIAN MOUNTED POLICEALLEGED HARASSMENT OF FAMILY OF
W. A. WILSON

Mr. Stanley Knowles (Winnipeg North Centre): I have a question for the Solicitor General, Mr. Speaker. Like other members I am anxious to help him get started on his second 30 years. In view of the report in yesterday's *Montreal Star* by W. A. Wilson of certain harassment of his family by the Royal Canadian Mounted Police, will the Solicitor General have an investigation made not only into this case but into the extent to which the RCMP is carrying on harassment of this kind?

Hon. G. J. McIlraith (Solicitor General): Mr. Speaker, I am quite familiar with the subject matter of the story in the *Montreal Star*. I must say that the part which related to me personally and to the allegations about the telephone call from me is totally wrong in substance and in fact. As to the other part of the article, I did check into that matter rather thoroughly myself because I was concerned in case there had been harassment by the police. I found that there was no harassment by the police but there was some unfortunate and improper conversation by the police in that case. However, they were properly there, for a proper purpose.

Mr. Knowles (Winnipeg North Centre): A supplementary question, Mr. Speaker. Will the minister deal with the other part of my question and inquire to find out whether this kind of harassment has taken place in other cases?

Mr. McIlraith: Mr. Speaker, I thought I made it clear that I found there was no harassment in this case. That being so, I do not know how I can find out if there is similar harassment in other cases. If the hon. gentleman has in mind any other case that he would care to mention, I will certainly have it looked into.
