FERRY RATE INCREASES IMPOSED BY CANADIAN NA-TIONAL RAILWAYS IN MARITIMES—REQUEST FOR STATEMENT BY MINISTER

The increase was made after a very close study of the matter. Further, the minister will be in the House on Tuesday and he will certainly be glad to answer any questions put by hon. members.

Mr. Marshall: On a point of order, Mr. Speaker, the parliamentary secretary has not answered the question. It has nothing to do with rail freight rates. It has to do with ferry rate increases between the provinces of Nova Scotia and Newfoundland.
