4. (a) As announced at the time the option was signed, the maximum budgetary outlay required for the purchase of Canadair is not expected to exceed \$38,150,000. An allowance was made for the purchase of Canadair under Vote L-20 which was approved in the 1975-76 Main Estimates for the Department of Industry, Trade and Commerce. (b) The assets of Canadair covered by the option agreement are all the assets except Canadair's investment in the Asbestos Corporation Limited. They include land, buildings, machinery, equipment, designs, copyrights, patents and so forth. One firm of appraisers estimated the total value of all such assets would amount to \$103 million after deducting outstanding liabilities. The Government is currently examining Canadair's sales potential together

#### MEETING OF MINISTERS AT MEACH LAKE

# Question No. 3,116-Mr. Clark (Rocky Mountain):

Did Mr. Michael Pitfield or any other individual who was not a Member of the House of Commons or the Senate participate in the meeting of Ministers at the National Capital Commission property on Meach Lake, Quebec on September 17, 1975 and, if so, what was their (a) name (b) position (c) reason for attending?

Hon. Mitchell Sharp (President of the Privy Council): The inner workings of cabinet, cabinet committees (including membership therein), and the services rendered by support staff are traditionally considered confidential matters. Canadian precedents in this regard flowed from British practice over many years. In response to a question in the House the Canadian Prime Minister of the day on February 4, 1960 in part replied: "The means by which the cabinet conducts its business are traditionally regarded as its own domestic affair, and questions on the subject are normally neither asked nor answered." A detailed answer to the question would be a departure from the traditional position that has always been taken that meetings of the cabinet are private and no information is given concerning attendance.
