merits, and will the Minister at the same time assure the House that those few potentially violent prisoners denied mandatory supervision will receive extensive rehabilitation so that there will not be an even greater risk to the community after they are simply warehoused for a longer period of time?

Hon. Bob Kaplan (Solicitor General of Canada): Madam Speaker, I do not know how they can receive extensive rehabilitation if they have been freed. They are in the community under mandatory supervision. That is the point. So far as introducing additional legislation in the House is concerned legislation has been introduced in Parliament which I consider satisfactory. It has the support of this Government. I hope that the Senate will deal quickly with it and send it to this Chamber where, in the Committee, the Hon. Member can make his points about it. If he has some improvements to suggest that provide greater safeguards of the right of the individual, and also adequate protection for the public, I am sure that the members of the Committee will be pleased to hear them.
