an interpretation of a newspaper article; this is a clear action by a Government employee to impede the voice and credibility of a Member of the House. That is the issue here. That is why I rise to support my colleague in asking that the Chair find a prima facie case that his ability has been impeded. In the earlier case, we stood with the Hon. Member for Lincoln and said; "Yes, your privilege has been impeded and it should be examined".

I ask Your Honour to find a prima facie case of privilege here and to support the Member in calling the civil servant in question to the bar of the House to make an apology.
