Article 11(e) establishes a right to social security, contrary to the government's clawback policy on pensions and on family allowances. Article 11(2)(c) speaks of a development of a network of child care facilities. Where is Canada's much needed child care program? Will this government once again introduce a program two months before an election, only to have it die once again on the Order Paper?

Articles 3 and 5 can be applied to bring in pornography legislation, legislation that attacks violence and pornography and not sexuality.

There are three other points made in Canada's second report on its implementation of the Convention that need examining. One is its glorification of the Court Challenges Program. I hope that this means that the program will be extended. The second is the repeal of discrimination in the Indian Act. However, there still does remain discrimination in the Act since reinstated women can only pass status down to the first generation while men can pass status down to subsequent generations.

The report also discusses the prison for women. I visited the Kingston prison for women and I found the conditions there just absolutely shocking. I would hope that in Canada's next report, there will be real, rather than imagined, progress to comment on as far as the prison for women in Kingston goes.

The preamble of the convention says that signatories are "concerned that in situations of poverty, women have the least access to food, health care, education, training and opportunities for employment and other needs, convinced that the establishment of the new international economic order, based on equity and justice, will contribute significantly towards the promotion of equality between men and women—".

In Canada, the devastating reality is that one in three female single parents in the paid workforce cannot keep her family out of poverty and 53.4 per cent of female-headed, single parent families are poor. Three-quarters of all poor seniors are women.

What we need to fulfil our convention obligations is really a new economic order, one that puts people first, one for which full employment is a priority, one that redistributes wealth, an economic order that is based on equality and justice for all.
