Ordered, That the Clerk do go down to the House of Commons and acquaint that House that the Senate have passed this Bill without any amendment.

The Order of the Day being read for putting the House into a Committee of the whole on the Bill intituled, "An Act respecting the Manufacture or Importation of Copper Coins or Tokens."

Hon. Mr. *Campbell* moved, seconded by the Honorable Mr. *Chapais*, That the same be postponed until Monday next.

After Debate,

The question of concurrence being put thereon, the same was resolved in the affirmative, and

Ordered accordingly.

The Order of the Day being read for the Second Reading of the Bill, intituled: "An Act respecting Offences against the Person."

The Honorable Mr. *Campbell* moved, seconded by the Honorable Mr. *Mitchell*, That the said Bill be now read a second time.

After debate,

The Honorable Mr. *Sanborn* moved in amendment, seconded by the Honorable Mr. *McCully*,

To leave out all the words after "be," and insert, "not now read a second time, but that it be resolved that at this late period of the Session, and in the absence of a large number of Senators, this Senate can not give the revision and assimilation of the Laws relating to the administration of Criminal Justice throughout the Dominion that deliberation and careful examination its importance deserves."
