SUCCESSION TAX DUTIES

AN AMENDMENT INTRODUCED IN THE LEGISLATURE.

Mr. Hardy favors the encouragement of New Industries - School Books to be Reduced in Price - Changes in the Act With Respect to Shipment of Fruit.

With the object of preventing persons evading the payment of succession duties, a number of cases having recently come to light, the Provincial Treasurer introduced a Government measure at yesterday's session of the Local Legislature.
