THE FREEDOM OF OLD LONDON GIVEN TO CANADIAN HEROES

Lord Mayor Entertained Them at Guildhall, When Col. Otter and Lord Strathcona Testified to Canada's Loyalty—Westminster Abbey and Buckingham Palace Visited.

London, Dec. 1.—The Canadians this afternoon visited the Guildhall, where the Lord Mayor again addressed them, thanking them for their services to the Empire.

Lord Strathcona's Words. Lord Strathcona and Mount Royal, the Canadian High Commissioners, before the British Parliament, were given the freedom of the city of London.

THE QUEEN WEPT. Her Majesty was moved to tears in addressing the troops—Col. Otter's Words Trembled.

London, Dec. 1.—(Special Cable Letter.)—The redeeming feature of the week from the British point of view, is the return of the Royal Canadian Regiment from South Africa, which affords the editorial writers a glorious opportunity for dilating on the loyalty and valor of the British Empire.

How truly pathetic was the meeting of the Queen and her Canadian soldiers seen by the eyes of the British people.

Attended Service in Westminster Abbey and Then Went on to the Guildhall.

London, Dec. 2.—Yesterday morning the members of the Royal Canadian Regiment attended service at Westminster Abbey, where they were given the freedom of the city of London.

It is the consensus of opinion among the shrewdest Canadians that all the hardships of South Africa were well worth going through if the end was to be such a hearty welcome as they have received in London.
