AND HIS RISE FROM ANY FEAR OF DISAPPOINTMENT WITH REFERENCE TO A SECOND CONTRACT, NOR WAS THE MONEY GIVEN WITH A VIEW OF SECURING IT, BUT IT WAS CAUSED BY A VERY RELATIONSHIP OF THE PARTIES, FROM THE AUTHORITATIVE POSITION HELD BY HON. MR. FLEMMING, AND POSSIBLY ALSO FROM AN APPREHENSION AS TO THE CONTINUANCE OF WHICH MIGHT AFFECT THE PERFORMANCE OF THE EXISTING CONTRACT IN CASE OF REFUSAL TO PAY.

THE CONTRACTOR, HAVING BEEN COMPELLED TO MAKE THE FIRST CONTRACT ENTERED INTO, WE THINK AND FIND THAT HON. MR. FLEMMING IS GUILTY OF THIS ACT OF COMPELSION WHICH IS IN ITSELF AGAINST HIM.
